Vesting of Crown Land in Litchfield Council

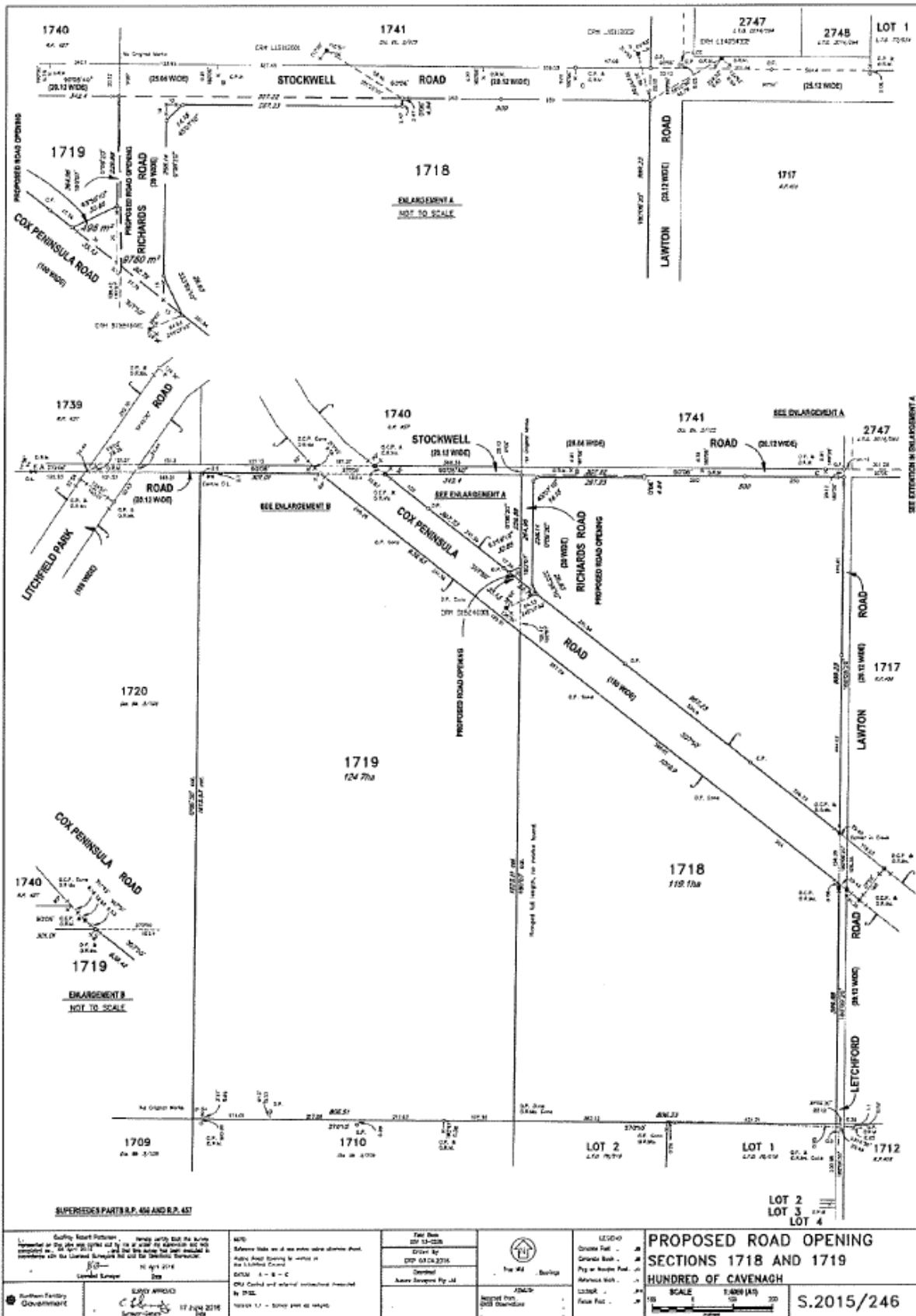
I, Chanston James Paech, Minister for Local Government:
