*Motor Vehicles Act 1949*

## **Exemption – Electric Trackless Tram and Passenger Carriages**

I, Cindy-Lee McDonald, Registrar of Motor Vehicles, under section 135(1) of the *Motor Vehicles Act 1949*, exempt the class of motor vehicle specified in the Schedule, Part 1, from the application of the provisions in Part 5A of the Act and in the *Motor Vehicles (Standards) Regulations 2003*, subject to the conditions set out in the Schedule, Part 2.

### **Schedule**

#### **Part 1            Electric Tram**

- 1        An electric trackless tram (the ***Electric Tram***) that:
  - (a)     is controlled and operated by the Territory Wildlife Park; and
  - (b)     has a vehicle identification number (***VIN***) of either 21401Q or 21402Q.
  
- 2        In this Schedule, a reference to the Electric Tram includes any trackless passenger carriage attached to the Electric Tram that:
  - (a)     is designed to be hauled by the Electric Tram; and
  - (b)     is controlled and operated by the Territory Wildlife Park; and
  - (c)     has a VIN of either 24102T1, 24102T2, 24101T1 or 24101T2.

#### *Note*

*An exemption from the application of certain provisions of the Traffic Act 1987 and Traffic Regulations 1999 has also been granted by the Registrar of Motor Vehicles under section 43B(1) of the Traffic Act 1987 for persons who are authorised drivers and passengers of the Electric Tram.*

**Part 2                    Conditions**

- 3     The Electric Tram must be registered and comply with the conditions of its registration at all times.
- 4     The Electric Tram may only be driven and operated on a route within the area of land comprising the Territory Wildlife Park in Berry Springs, Northern Territory.
- 5     The Electric Tram may only be operated or driven by a person (an **authorised driver**) who:
  - (a)    is an employee of the Territory Wildlife Park; and
  - (b)    holds a current Medium Rigid (MR) licence to drive; and
  - (c)    has completed the driver training and assessment required under clause 6.
- 6     For clause 5(c), before a person drives or operates the Electric Tram, the person must:
  - (a)    undertake a program of training with a driving instructor approved under section 25B of the Act; and
  - (b)    following completion of the training, be assessed by the driving instructor as capable of driving and operating the Electric Tram within the Territory Wildlife Park.
- 7     The Electric Tram must not be driven or operated by an authorised driver if the authorised driver has:
  - (a)    any alcohol on the driver's breath or in the driver's blood; or
  - (b)    any prohibited drug, within the meaning of section 19A of the *Traffic Act 1987*, in the driver's blood.
- 8     Flashing warning lights must be:
  - (a)    fitted to the Electric Tram; and
  - (b)    operational and in use at all times while the Electric Tram is being operated by an authorised driver.

- 9 The Electric Tram must be used, operated and maintained in accordance with the vehicle manual provided by the manufacturer of the Electric Tram, including in relation to:
- (a) its battery; and
  - (b) its weight capacity; and
  - (c) the tyre pressure of its tyres; and
  - (d) the lighting and warning devices fitted to it; and
  - (e) its speed; and
  - (f) if any modifications have been made to it – those modifications.
- 10 The Electric Tram must:
- (a) not be operated outside of its manufacturer's component or design limitations; and
  - (b) be maintained according to its manufacturer's specifications.
- 11 A risk assessment plan for the operation of the Electric Tram must be prepared and approved by the Department of Tourism and Hospitality, and the Electric Tram must be operated in accordance with the approved plan.
- 12 The Territory Wildlife Park must report any accident or safety incident involving the Electric Tram or arising from its operation to the Chief Transport Inspector, Department of Logistics and Infrastructure, as soon as is reasonably practicable after the accident or incident occurs.
- 13 The Territory Wildlife Park must maintain a record of the following matters:
- (a) all persons who are authorised drivers for the Electric Tram, including:
    - (i) the person's position number or AGS number; and
    - (ii) the date on which the person was assessed as capable of driving the Electric Tram in accordance with clause 6(b);
  - (b) the driving instructor and program of training referred to in clause 6;

- (c) any accident or safety incident referred to in clause 12.

*Traffic Act 1987*

### **Exemption – Drivers and Passengers of Electric Trackless Tram**

I, Cindy-Lee McDonald, Registrar of Motor Vehicles, under section 43B(1) of the *Traffic Act 1987*:

- (a) exempt a person who is a driver of the motor vehicle specified in the Schedule, Part 1, from the application of section 32(1) of the Act and regulation 7 of the *Traffic Regulations 1999*, subject to the conditions set out in the Schedule, Part 2; and
- (b) exempt a person who is a passenger of the motor vehicle specified in the Schedule, Part 1, from the application of regulation 7 of the *Traffic Regulations 1999*, subject to the conditions set out in the Schedule, Part 3.

### **Schedule**

#### **Part 1            Electric Tram**

- 1     An electric trackless tram (the ***Electric Tram***) that:
- (a)   is controlled and operated by the Territory Wildlife Park; and
- (b)   has a vehicle identification number (***VIN***) of either 21401Q or 21402Q.
- 2     In this Schedule, a reference to the Electric Tram includes any trackless passenger carriage attached to the Electric Tram that:
- (a)   is designed to be hauled by the Electric Tram; and

- (b) is controlled and operated by the Territory Wildlife Park; and
- (c) has a VIN of either 24102T1, 24102T2, 24101T1 or 24101T2.

*Note*

*An exemption from the application of certain provisions of the Motor Vehicles Act 1949 and Motor Vehicles (Standards) Regulations 2003 has also been granted by the Registrar of Motor Vehicles under section 135(1) of the Motor Vehicles Act 1949 in respect of the Electric Tram.*

## **Part 2            Conditions for drivers of Electric Tram**

### **Division 1        Authorised drivers**

- 3     A person (an ***authorised driver***) may only drive or operate the Electric Tram if the person:
- (a) is an employee of the Territory Wildlife Park; and
  - (b) holds a current Medium Rigid (MR) licence to drive; and
  - (c) has completed the driver training and assessment required under clause 4.
- 4     For clause 3(c), before driving or operating the Electric Tram, a person must:
- (a) undertake a program of training with a driving instructor approved under section 25B of the *Motor Vehicles Act 1949*; and
  - (b) following completion of the training, be assessed by the driving instructor as capable of driving and operating the Electric Tram within the Territory Wildlife Park.

### **Division 2        Operation of Electric Tram**

- 5     An authorised driver may only drive or operate the Electric Tram on a route within the area of land comprising the Territory Wildlife Park in Berry Springs, Northern Territory.
- 6     An authorised driver must not operate or drive the Electric Tram if the authorised driver has:
- (a) any alcohol on the driver's breath or in the driver's blood; or
  - (b) any prohibited drug in the driver's blood.

- 8 An authorised driver must ensure that the flashing warning lights fitted to the Electric Tram:
  - (a) are operational before driving or operating the Electric Tram; and
  - (b) in use while driving or operating the Electric Tram.
- 9 An authorised driver must ensure the Electric Tram is driven or operated:
  - (a) in accordance with the vehicle manual provided by its manufacturer; and
  - (b) within its manufacturer's component or design limitations; and
  - (c) in accordance with a risk assessment plan approved by the Department of Tourism and Hospitality for the Electric Tram.
- 10 An authorised driver must ensure that all passengers of the Electric Tram are seated, and remain seated, while the Electric Tram is in motion.

**Part 3                    Conditions for passengers of Electric Tram**

- 11 A person may only ride as a passenger on the Electric Tram on a route within the area of land comprising the Territory Wildlife Park in Berry Springs, Northern Territory.
  - 12 A person who is a passenger on the Electric Tram must:
    - (a) remain seated at all times while the Electric Tram is in motion; and
    - (b) comply with all instructions given by the authorised driver of the Electric Tram to the passengers on it.
