Palmerston CBD

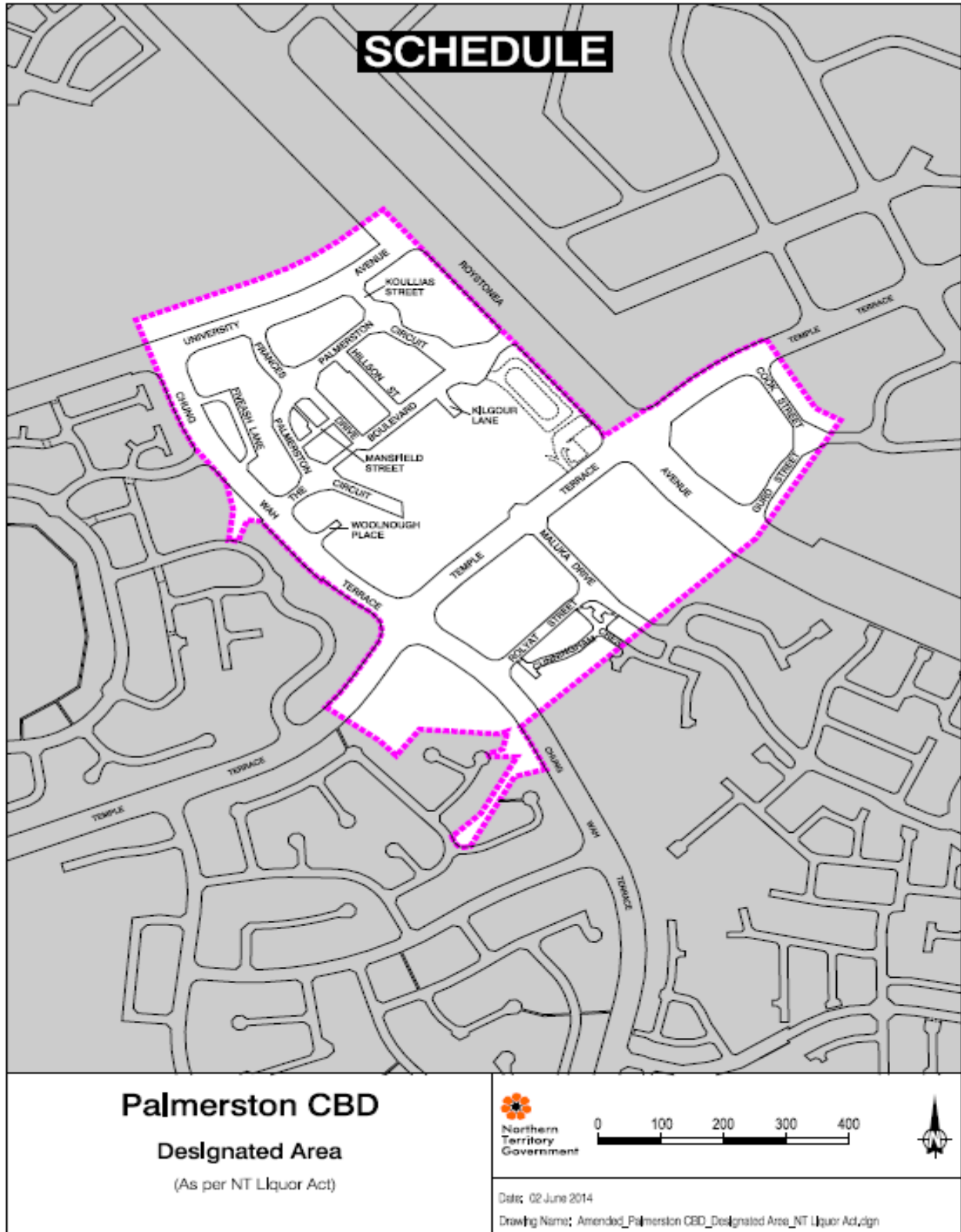
I, Peter Donald Styles, Minister for Racing, Gaming and Licensing, with effect on and from 3 August 2015:
