Control of Roads Act

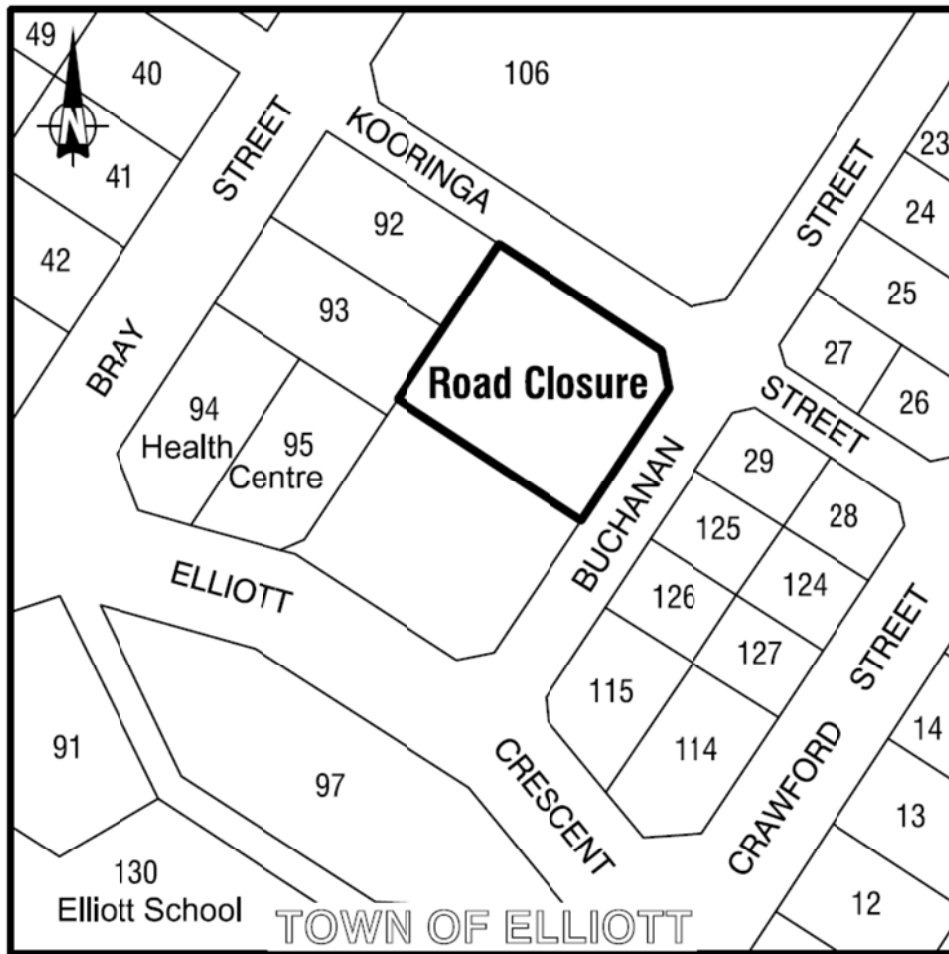
Order to Close Part of Road
