Legal Profession Act 2006

1. The Law Society Northern Territory pursuant to section 375(2) of the *Legal Profession Act 2006* (the Act) and in accordance with the conditions set out in paragraph 3 of this instrument exempts local legal practitioners holding or seeking to hold **barrister practising certificates** under the Act to (practising only in the manner of a barrister), from compliance with the section 376 of the Act.
2. Pursuant to section 375 (2) of the Act, the period of exemption will be from **4.00pm on 30 June 2014 to 4.00pm on 30 June 2015**, unless the instrument is earlier terminated by the Law Society Northern Territory.
3. The exemption is subject to the following conditions:
 - (a) The **barristers** that are covered by this exemption must maintain professional indemnity insurance with respect to their legal practice, which contains terms and conditions accepted by the Law Society Northern Territory (accepted alternative policy).
 - (b) The **barristers** that are covered by this exemption must provide to the Law Society Northern Territory a copy of the terms of the accepted alternative policy and provide satisfactory evidence to the Law Society Northern Territory that they are covered by the accepted alternative policy.
