1. Citation

This amendment to the NT Planning Scheme may be cited as Amendment No. 34.


2. Definitions

In this amendment –

- "amending map" means the map, signed by the Minister for Planning and Lands and marked "NT Planning Scheme Amendment No. 34", deposited in the office of the Department of Planning and Infrastructure, Darwin;
- "zoning map" means the zoning map within the meaning of the NT Planning Scheme.

3. Amendment of zoning map

The NT Planning Scheme is amended by amending the zoning map relating to Darwin to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered "R", which is part Section 4440 (10) Boulter Road, Hundred of Bagot.

Reason for Decision

NT PLANNING SCHEME AMENDMENT AMENDMENT No. 34

- 1. In the development of the consolidated NT Planning Scheme, every zone was translated to an equivalent new Scheme zone. Generally zones were able to translate directly.
- 2. An error was made in the translation of part Section 4440 (10) Boulter Road, Hundred of Bagot. The parcel was partly within Zone RC (Restricted Agriculture) of the Darwin Town Plan on 31 January 2007 and that part of the land should have translated to Zone R (Rural). The new zoning maps indicate that the land is entirely with Zoned RD (Restricted Development).
- 3. This amendment rezones that portion of the land that was previously within Zone RC to Zone R to ensure consistency with the zoning translation parameters that were applied across the Northern Territory.
