# **Reasons for Decision**

# NORTHERN TERRITORY PLANNING SCHEME AMENDMENT AMENDMENT No. 281

The amendment will facilitate the development of the site for medium density residential development, under the requirements of the NT Planning Scheme.

The site is considered suitable to support the dwelling density envisaged under Zone MR (Medium Density Residential) provisions.

The range of land uses allowed for under Zone MR (Medium Density Residential) emphasise that any subsequent development/use of the site will continue to be for residential purposes.

The amendment will allow infill development for multiple dwellings and will provide the potential for greater housing choice and type in Alice Springs. Multiple dwelling development of this site would be consistent with several other developments within the area.

The amendment is considered to be consistent with the strategic direction provided by the Northern Territory Planning Scheme, in particular the Planning Principles for Alice Springs which supports maximising options for urban infill.

Amendment No. 281 rezones Lot 2663 (19) South Terrace, Alice Springs to Zone MR (Medium Density Residential).

# AMENDMENT No. 281

#### 1. Citation

This amendment to the NT Planning Scheme may be cited as Amendment No. 281.

### 2. Definitions

In this amendment –

"amending map" means the map, signed by the Minister for Lands and Planning and marked "NT Planning Scheme Amendment No. 281", deposited in the office of the Department of Lands, Planning and the Environment, Darwin;

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

# 3. Amendment of zoning map

The NT Planning Scheme is amended by amending the zoning map relating to Alice Springs to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered "MR", which is Lot 2663 (19) South Terrace, Town of Alice Springs.
