DARWIN HARBOUR STRATEGY

One of the key deliverables of the Darwin Harbour Advisory Committee is to review and update the Darwin Harbour Strategy. The former Darwin Harbour Advisory Committee prepared a Darwin Harbour Strategy in June 2010. The strategy was a comprehensive guide for the responsible stewardship and sustainable development of the Darwin Harbour region. It is timely that the Strategy be reviewed.

The Department of Environment and Natural Resources has appointed an officer to undertake this task on a part-time basis over a period of 3 months and a working group has been established to guide the revision and update of the Strategy.

DARWIN HARBOUR REPORT CARDS

Another key deliverable for the DHAC is the Darwin Harbour Report Cards. The Committee has been gathering information around options for a dynamic web based report card with biological health indicators and trends which will incentivise stewardship. At their meeting in February the following presentations were delivered to the Committee:

- Ms Jane Thomas Science Communicator NESP Northern Australia Environmental Resources Hub at Charles Darwin University described her previous experience with the Integration and Application Network and discussed stakeholder engagement processes, website display options, and approaches for measuring non-ecological indicators for report cards.
- Mr Murray Logan Biostatistician and Mr Richard Brinkman Research Program Leader from the Australian Institute of Marine Science gave a joint presentation that summarised their previous experience working on the Gladstone Harbour report card.







PLANNING AND DEVELOPMENT WORKSHOP

The Darwin Harbour Advisory Committee held their first workshop with the theme 'Planning and Development'. The workshop was held at Charles Darwin University on Monday 5 April 2018 between 9:00am and 3:30pm.
