- the name and address of the licence holder
- the date on which the licence is due to expire
- the location of the property from which the water is currently taken
- the maximum quantity of water that may be taken annually
- the source of the water that may be taken.

In the spirit of transparency, the Controller of Water Resources (and the department) will also make a copy of any licence associated with this notice publicly available from the department's website.

The Controller of Water Resources has the power to suppress information if satisfied there are grounds of commercial confidentiality. You may apply to have commercially confidential information withheld by using the appropriate approved application form available from the department's website.
