1. Citation

This amendment to the NT Planning Scheme may be cited as Amendment No. 512.

2. Definition


In this amendment -

"amending map" means the map, signed by the Minister for Infrastructure, Planning and Logistics and marked "NT Planning Scheme Amendment No. 512", deposited in the office of the Department of Infrastructure, Planning and Logistics, Darwin;

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

3. Amendment of Zoning Map

The NT Planning Scheme is amended by amending the zoning map relating to Alice Springs to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered RL which includes part of Lots 10549, 10550 and 10616 Heenan Road, Suburb of Ross, Town of Alice Springs.

Reasons for Decision

NORTHERN TERRITORY PLANNING SCHEME AMENDMENT No. 512

A planning scheme amendment for part of Lots 10549, 10550 and 10616 Heenan Road, Suburb of Ross, Town of Alice Springs for rezoning from Zone R (Rural) to Zone RL (Rural Living) is supported as it:

- is consistent with the direction provided by Alice Springs Regional Land Use Plan 2016;
- will eliminate potential land use 'friction' between potentially incompatible uses which are permitted in Zone R, but not in Zone RL; and
- will provide a more consistent zoning pattern with other rural living lots on Heenan Road.

The proposed amendment is considered to be a normalisation process of amending the NT Planning Scheme following approved subdivisions, by introducing a consistent zoning over all three lots to enable the orderly use and development of each lot under Zone RL (Rural Living), in accordance with the provisions of the NT Planning Scheme.
