Naming of Place  
Locality of Gurindji

I, Dawn Lawrie, Chairperson of the Place Names Committee for the Northern Territory, as the delegate of the Minister for Lands, Planning and the Environment:

- (a) under section 11(1)(a) of the *Place Names Act* and with reference to section 43 of the *Interpretation Act*, revoke the instrument entitled "Naming of Places" dated 8 March 2007, notice of which was published in *Gazette* No. G14 of 4 April 2007, to the extent it names Gurindji; and
- (b) under section 11D(1) of the *Place Names Act*, give notice that:
  - (i) on the recommendation of the Committee, I have approved the naming of the locality of Gurindji; and
