

AMENDMENT OF NT PLANNING SCHEME

AMENDMENT No. 311

1. Citation

This amendment to the NT Planning Scheme may be cited as Amendment No. 311.

2. Amendment

The NT Planning Scheme is amended by amending clause 1.3 Exceptions by inserting at the end of the clause:

- (i) the erection of a 17m high projection screen in association with the Blatherskite Park Showgrounds on Lot 5687, Town of Alice Springs.

Reasons for Decision

NORTHERN TERRITORY PLANNING SCHEME AMENDMENT **AMENDMENT No. 311**

Amendment No. 311 amends clause 1.3 Exceptions of the NT Planning Scheme to allow the placement of a 17m high projection screen on Lot 5687, Town of Alice Springs in conjunction with the existing Blatherskite Park Showground.

The provision of the screen within the Showgrounds complex is supported as:

- The screen is the same height and dimensions as it was on the old Drive-In site, which was in place prior to the introduction of building height limits in the mid 1980s;
- The screen was until recently heritage listed, but still has significant community support for its continued use;
- The new site for the screen is well within the confines of the Blatherskite Park Showground and is unlikely to be seen from adjoining public spaces nor likely to adversely impact on the visual amenity of the area;
- The screen will complement the activities already conducted on the site and provide opportunities for greater benefits to the community;
- The height of the screen is comparable with the existing grandstand seating building; and
- The proposed orientation of the screen and retention of several tall trees behind it will assist in filtering of any potential negative effect of light spill from the site.
