Notes for Guidance:

- This form is only for the use of LMVD's who currently hold a Dealer Authorisation Identity Certificate (DAIC)
- This form is to be used for transfer of ownership of a Northern Territory registered vehicle into LMVD name only. Form R11 "Apply to register a vehicle in the NT or transfer an NT registered vehicle" is required for interstate vehicles because additional vehicle information is required.
- Show the names and addresses of sellers (eg the last registered owner), as shown on the Certificate of Registration. If seller is not the last registered owner of the vehicles, transfer cannot be processed.
- For disposals, use Form 'R15 – Bulk notice of disposal for licenced vehicle dealers and auction houses'
