**Revocation of Reservation of Blocks – RB 61**

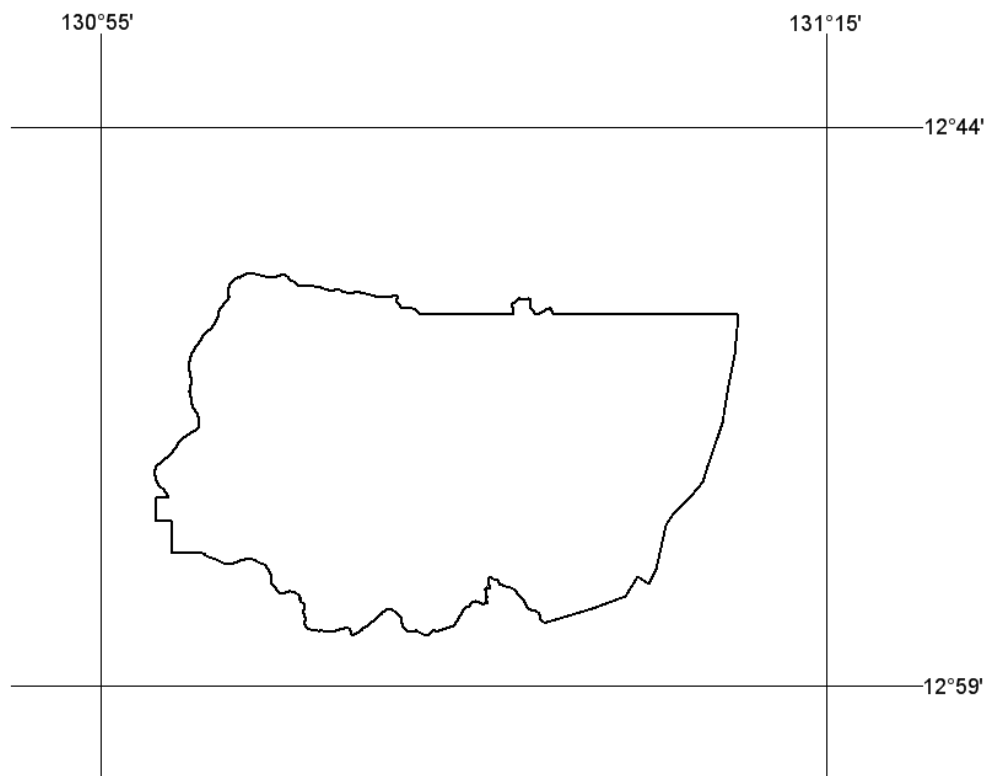

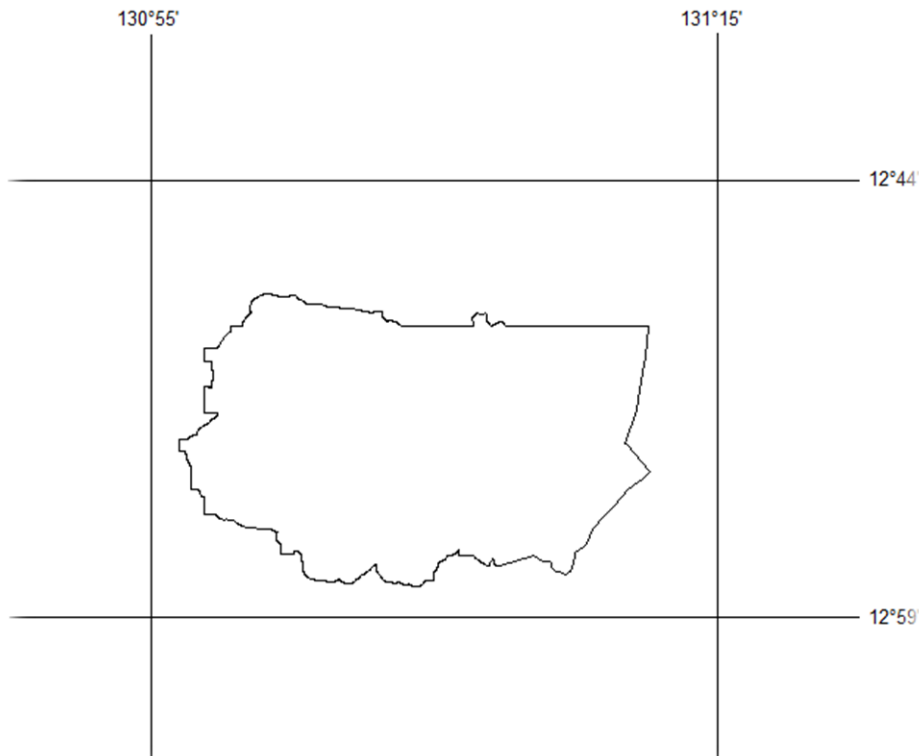
Reservation of Blocks – RB 68

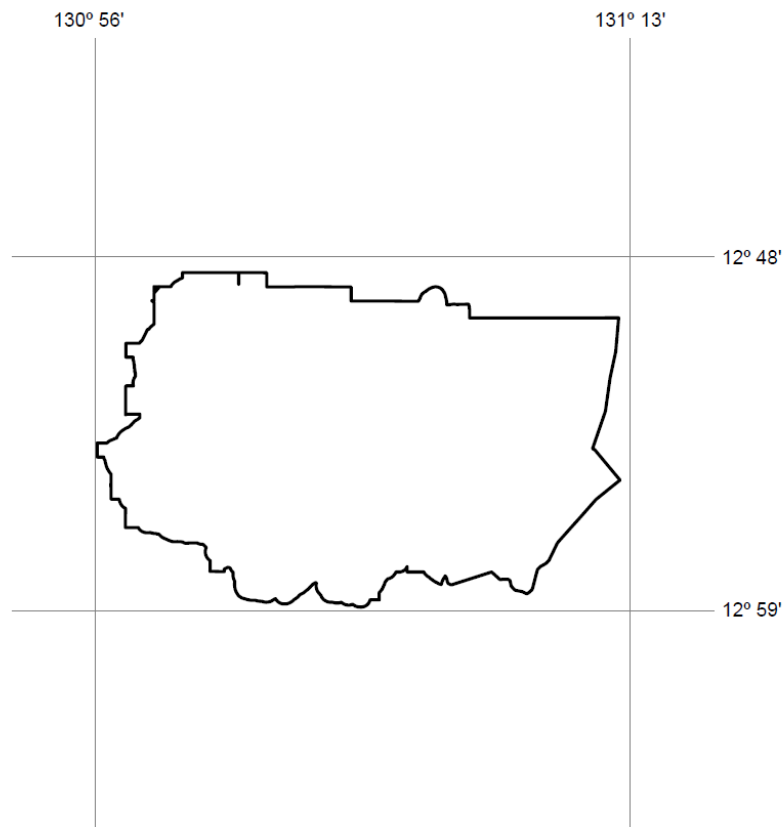
**Reservation of Blocks – GRO 7**
