Water Act 1992

Specification of criteria for granting licences exceeding 10 years under section 45(4)(a) and 60(4)(a) of the Act

I, Eva Dina Lawler, Minister for Environment, under sections 45(4)(a) and 60(4)(a) of the *Water Act 1992* (the **Act**) specify the criteria set out in the Schedule, Part A or B as justifying the grant of a licence for a period exceeding 10 years.

Part A – Public water supply criteria

The criteria are the following:

- (a) the purpose of the proposed licence is to take water for the beneficial use of public water supply;
- (b) the proposed licensee is:
 - (i) the Power and Water Corporation established by section 4 of the *Power and Water Corporation Act 1987*; or
 - (ii) Indigenous Essential Services Pty Ltd (ACN 105 269 636);
- (c) the water proposed to be taken under the licence will provide source water for drinking purposes delivered through community water systems;
- (d) the Controller is satisfied the expected impact on water resources of the Territory of taking water under the proposed licence has been assessed with a high degree of certainty.

Part B – Criteria for renewal for licence holder demonstrating long-term compliance on a sound scientific basis

The criteria are the following:

- (a) the applicant is applying under section 45(1) or 60(1) of the Act to renew a licence that was granted for a period of 10 years or more;
- (b) the applicant and any previous holder of the licence has demonstrated consistent compliance with the terms and conditions specified in the licence document;
- (c) the Controller is satisfied the expected impact on water resources of the Territory of taking water under the proposed licence has been assessed with a high degree of certainty;
- (d) the application is to renew the licence for a period not exceeding 30 years.
