**Notice of establishment of Catholic Church Diocese of Darwin
Education Property Trust**

Notice is given, pursuant to sections 3 and 6 of the *Catholic Church in the Northern Territory Act 1979* (NT) that I Charles Gauci the Bishop of the Diocese of the Catholic Church of Darwin make the following by-laws which may be cited as the *Catholic Church Diocese of Darwin Education Property Trust By-laws*:

1. There is established by these by-laws a property trust in respect of the Diocese of Darwin.
2. The name of the property trust established by By-law 1 is the Catholic Church of the Diocese of Darwin Education Property Trust.
3. That a matter relating to the regulation, management or administration of the property trust established by By-law 2 may be provided for by rules, not inconsistent with the Act or the by-laws made by the property trust from time to time.
