Notice is hereby given pursuant to section 54(2) of the *Associations Act 2003* that in pursuance of a resolution of the above association passed on

It is the intention of the Association that, in accordance with s 54(1) of the *Associations Act 2003*, all of the real and personal property of the Association be transferred in the manner set out below on the expiration of 28 days after the publication of this notice, with the consequence that the Association shall thereafter be dissolved by operation of s 54(7) of the Act.

Following the satisfaction of all the Association's debts and liabilities the remaining assets, consisting of cash only (hereinafter "**surplus cash**"), shall not be distributed to the members, but shall instead be given or transferred, in the proportions of surplus cash as specified below, to the bodies identified below which have demonstrated that they:

- (a) have similar objects or purposes; and
- (b) are not carried on for profit or gain to their individual members;

as determined by resolution of the members of the Association.

The Association has 156 members.

The relevant bodies, and the proportions of surplus cash to be transferred to each such body, are as follows:

- A) Anguladj Aboriginal Corporation (ICN: 9671):
 - 6/156th of the surplus cash of the Association (ie 3.85% rounded to two decimal places);
- B) Djabulukgu Association Incorporated (ABN: 56 936 364 456):
 - 19/156th of the surplus cash of the Association (ie 12.18% rounded to two decimal places);
- C) Djardi Aboriginal Corporation (ICN: 9686):
 - 5/156th of the surplus cash of the Association (ie 3.21% rounded to two decimal places);

- L) Pine Creek Aboriginal Corporation (ICN: 9943):
 - 12/156th of the surplus cash of the Association (ie 7.69% rounded to two decimal places);
- M) Role Aboriginal Corporation (ICN: 9925):
 - 2/156th of the surplus cash of the Association (ie 1.28% rounded to two decimal places);
- N) Unborbelere Aboriginal Corporation (ICN: 9990):
 - 1/156th of the surplus cash of the Association (ie 0.64% rounded to two decimal places);

- O) Wurngomgu Aboriginal Corporation (ICN: 9666):
- 4/156th of the surplus cash of the Association (ie 2.56% rounded to two decimal places).

Any member or creditor of the association may, within 28 days after the date of the publication of this notice, make application to the Supreme Court for an order prohibiting the proposed transfer of property.
