Traffic Act 1987

Approved Bicycle Helmet

I, Cindy-Lee McDonald, Registrar of Motor Vehicles, under section 10A(1)(b) of the *Traffic Act 1987*, and with reference to subregulation 86(3)(b) of the *Traffic Regulations 1999*, approve the types or classes of bicycle helmets under the Schedule to this instrument.

Schedule

- a) Australian/New Zealand Standard AS/NZS 2063:2008 – Bicycle helmets;
or
- b) Australian/New Zealand Standard AS/NZS 2063:2020 – Helmets for use on bicycles and wheeled recreational devices; or
- c) European Standard EN 1078:2012+A1:2012 – Helmets for pedal cyclists and for users of skateboards and roller skates; or
- d) Snell B-95 1995 Bicycle Helmet Standard, 1998 revision, Standard for Protective Headgear for Use in Bicycling; or
- e) American Society for Testing and Materials Standard (ASTM) International Standard F1447:2018, Standard Specification for Helmets Used in Recreational Bicycling or Roller Skating; or
- f) US Consumer Product Safety Commission Standard 16 C.F.R. Part 1203, Safety Standard for Bicycle Helmets.

Note

The Dictionary in Schedule 3 to the Traffic Regulations 1999 – the Australian Road Rules defines "approved bicycle helmet" to mean a protective helmet for bicycle riders that is approved, for the Australian Road Rules, under subregulation 86(3)(b) of the Traffic Regulations 1999.
