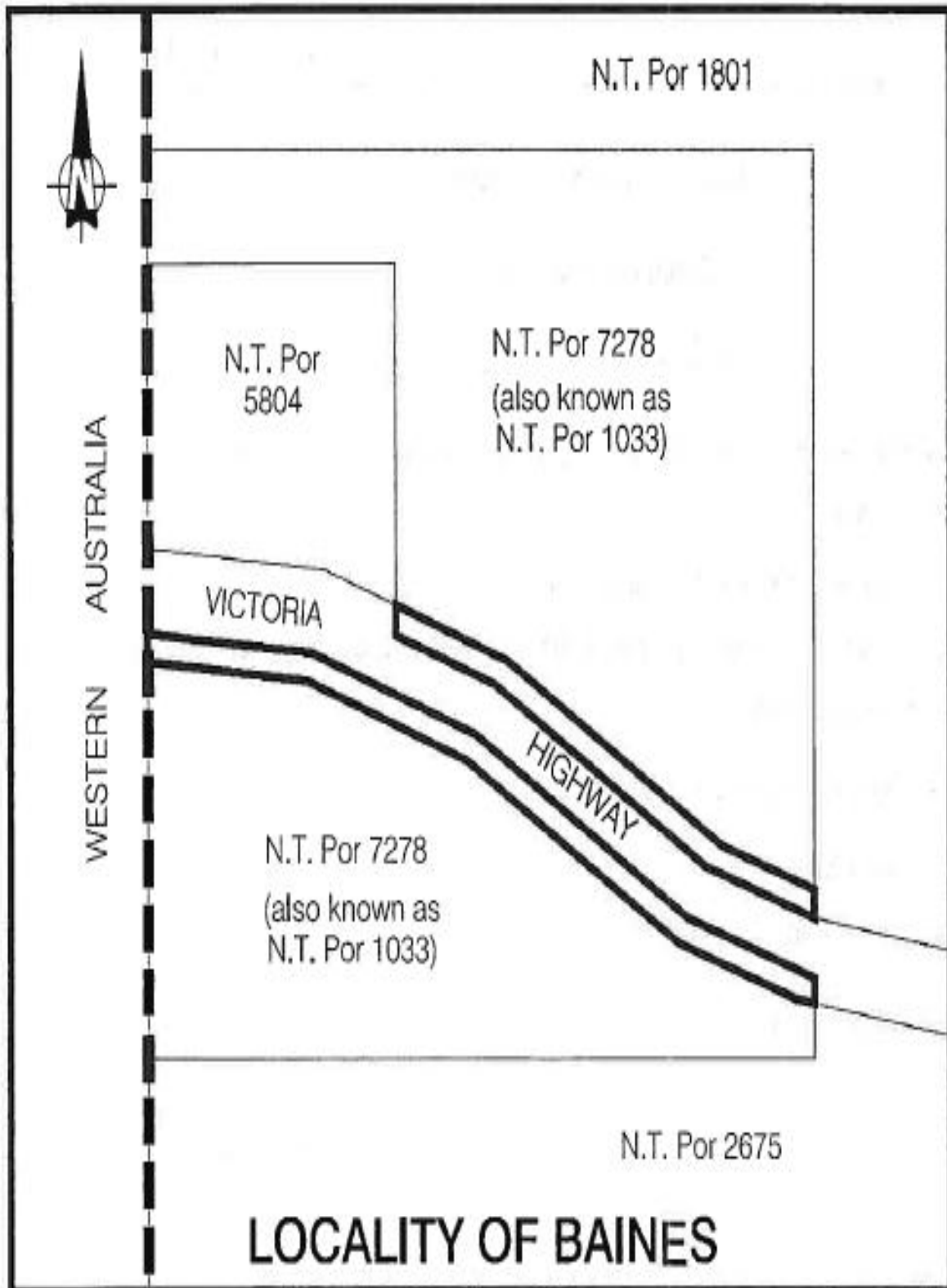
Order to Open Road
