Establishment of Group School Management Councils

I, Peter Glen Chandler, Minister for Education:

- (a) under section 71(5)(b) of the *Education Act* and with reference to section 43 of the *Interpretation Act*, revoke the establishment of group school management councils effected by *Gazette* notice dated 29 January 2014 published in *Gazette* No. G6 of 12 February 2014; and
- (b) under section 71(5)(b) of the *Education Act*, establish each group school management council specified in the Schedule for the Government schools specified opposite the school council; and
- (c) under section 71(8) of the Act and with reference to section 71(9) of the Act, appoint the person from time to time holding, acting in or performing the duties of the position specified in the Schedule opposite a group school management council to comprise that school council.
