Mineral Titles Act

General Reservation of Land
(RL 30241)

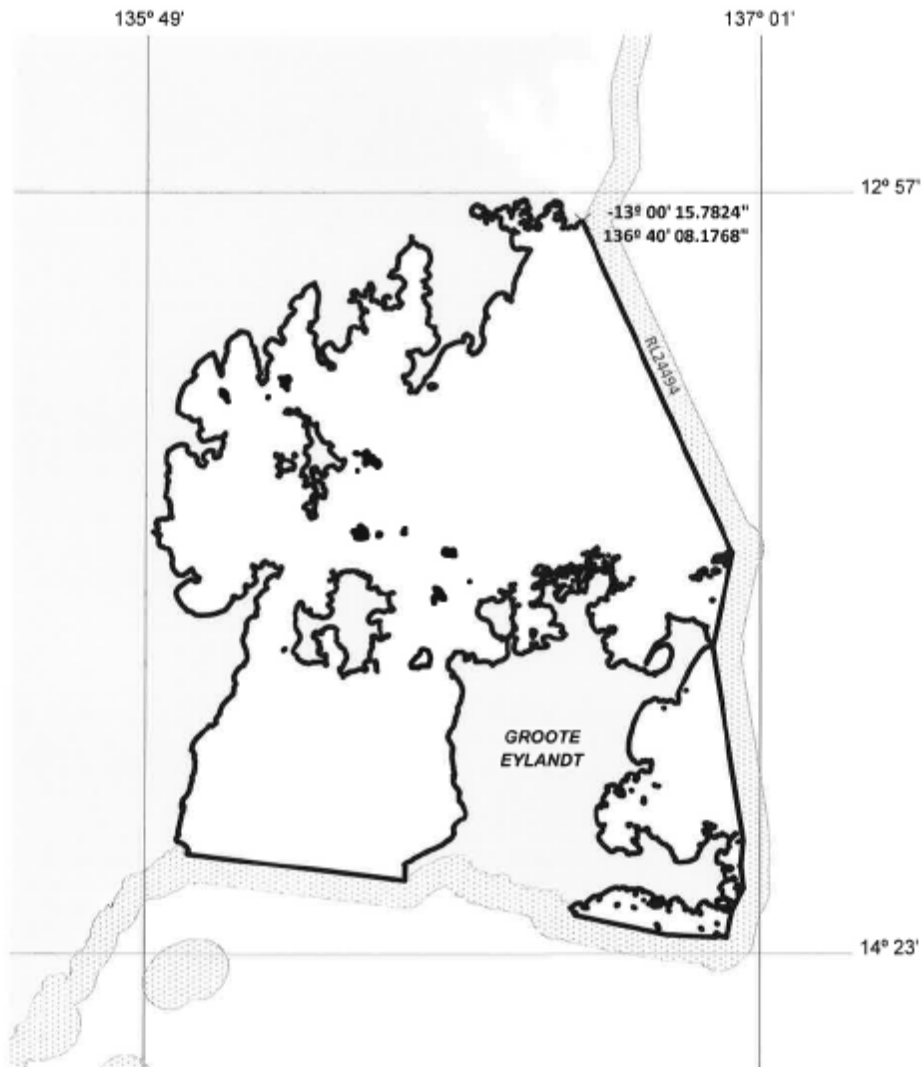
I, Alan Charles Holland, Director Mineral Titles, as delegate for the Minister for Mines and Energy, under section 113 of the *Mineral Titles Act*:

- (a) reserve the land in the Bickerton locality that is shown unshaded within the thick black lines on the plan in the Schedule from the following activities:
 - (i) exploration for minerals generally;
 - (ii) extraction of minerals generally;
 - (iii) exploration for extractive minerals; and
 - (iv) extraction of extractive minerals; and
- (b) give notice that:
 - (i) the reservation takes effect on the day this notice is published in the *Gazette*; and
 - (ii) the land is being reserved to assess the actual or potential impact of seabed mining activities on the fauna and flora of the land; and
 - (iii) a person is not entitled to apply for the grant of any mineral title in relation to the land.
