- Signing means that you give your undertaking, or make your election, as detailed in the section.
- Ensure that you have completed the Personal Details section.
- Submit this form at an MVR office or remote Police Station **within 21 days from the Notice date printed on your Notice**. If you are not submitting this form in person, you must provide a clear copy of both sides of your current Northern Territory drivers licence with this application.

Option 1: 12 Month Good Driving Behaviour Option

In relation to my Notice, I **undertake to be of good driving behaviour for 12 months acknowledging that:**

1. I have read and understand the options contained in my Notice;
2. I am the holder of a current NT drivers licence and therefore eligible to undertake to be of good driving behaviour (GDB);
3. The GDB period will begin the day after this undertaking is accepted by an MVR outlet (e.g. if this undertaking is lodged today at an MVR outlet, the GDB period will begin at midnight tonight; if it is lodged today at a remote Police Station after normal business hours, the GDB period will begin at the end of the next working day at midnight);
4. If my licence expires during the GDB period, the GDB period continues to run and I must renew my licence in the usual way to avoid driving illegally;
5. If I accrue **2 or more** demerit points within the GDB period my licence to drive will be suspended for a period that is **double** the period that was specified in my Notice;
6. The GDB period ceases to run (or does not begin to run) during a period of licence suspension or disqualification under another law, and resumes (or starts as the case may be) immediately after the licence suspension or disqualification ends; and
7. The GDB period is for a total of 12 months – this is not negotiable.

Option 2: Early Start to Suspension Application

In relation to my Notice, I **elect to begin my Suspension Period earlier than the effective date in the Notice acknowledging that:**

1. I have read and understand the options contained in my Notice;
2. The Suspension Period will begin the day after this election is accepted by an MVR outlet (e.g. if this election is lodged today at an MVR outlet, the suspension will begin at midnight tonight; if it is lodged today at a remote Police Station after normal business hours, the suspension will begin at the end of the next working day at midnight);
3. If my driver licence expires during the Suspension Period, the Suspension Period continues to run;
4. The Suspension Period will cease to run (or will not begin to run) during a period of licence suspension or disqualification under another law (other than for fine default), and will resume (or commence as the case may be) immediately after the other period ends;
5. If my licence is or has been suspended due to fine default and that suspension overlaps the Suspension Period, the periods will run concurrently; and
6. Suspension of my driver licence may disqualify me from driving elsewhere in Australia (and other countries) for the Suspension Period.
