Before you fill in the form

You must read the options explained on the rear of your Notice of Suspension or Good Driving Behaviour Option (your “notice”).

Once you have decided on the option that is right for you, do the following:

- complete the personal details section on this form
- read the relevant ‘option’ section below, then sign and date to confirm your chosen option
- submit this completed form within 21 days from the notice date printed on your notice.

Refer to page two for information about how to submit this form. If you submit the form by email, you must include a copy of your signed driver licence.

Option 1: Early start to suspension application			
In relation to my notice,			
I elect to begin my suspension period earlier than the effective date in the notice acknowledging that:			
<ol style="list-style-type: none">1. I have read and understand the options contained in my notice2. The suspension period will begin the day after this election is accepted by MVR (e.g. if this undertaking is lodged during MVR business hours today the suspension will begin after midnight tonight)3. If my driver licence expires during the suspension period, the suspension period continues to run4. The suspension period will cease to run (or will not begin to run) during a period of licence suspension or disqualification under another law (other than for fine default), and will resume (or commence as the case may be) immediately after the other period ends5. If my licence is or has been suspended due to fine default and that suspension overlaps the suspension period, the periods will run concurrently6. Suspension of my driver licence may disqualify me from driving elsewhere in Australia (and other countries) for the suspension period.

Option 2: 12 month good driving behaviour

In relation to my notice,

I undertake to be of good driving behaviour for 12 months acknowledging that:

1. I have read and understand the options contained in my notice
2. I am the holder of a current NT drivers licence and eligible to undertake to be of Good Driving Behaviour (GDB)
3. The GDB period will begin the day after this undertaking is accepted by MVR (e.g. if this undertaking is lodged during MVR business hours today the GDB period will begin after midnight tonight)
4. If my licence expires during the GDB period, the GDB period continues to run and I must renew my licence in the usual way to avoid driving illegally
5. If I accrue **2 or more** demerit points within the GDB period my licence to drive will be suspended for a period that is **double** the period that was specified in my notice
6. If another disqualification or suspension starts while I am serving the GDB period, the 12 month period is paused and will not restart until the other disqualification or suspension period ends.
7. The GDB period is for a total of 12 months – this is not negotiable.

Applicants are ineligible for the GDB option if the demerit point suspension has already commenced. Refer to your notice to confirm your suspension start date.
