- Insolvency check provided by the Australian Financial Security Authority (AFSA). Insolvency checks
 must be an original document or certified copy supplied by AFSA and be no more than 3 months old
 at time of application.
- Body corporates and incorporated associations must submit a current company extract from the Australian Securities & Investment Commission (ASIC).
- For new applications only, body corporates and incorporated associations must submit a copy of their constitution or company documents, which confirm the company is authorised under its constitution to provide a CPV transport service.
- New applications will not be accepted unless all supporting documents are included at time of applying, including the \$100 application fee. All applications must be submitted to a Motor Vehicle Registry (MVR) office.

If you intend to operate a commercial passenger vehicle (CPV), please complete an application for a Commercial Vehicle Licence - CPVF02.

If you do not intend to operate a CPV at this time, you will need to complete an application for a Commercial Vehicle Licence - CPVF02 prior to operating. This form can be found at nt.gov.au/driving/industry
