Northern Territory Electricity Ring-fencing Code (version 3)

As a result of the review, the Commission has varied the Northern Territory Electricity Ring-fencing Code (version 3), and has revoked the Ring-fencing Guidelines (version 1). The variations to the Code and revocation of the Guidelines will take effect on the date of publication of this notice.
