## Traffic Act 1987

#### Notice of Approval of Traffic Infringement Detection Device, Specification of Manner and Frequency of Device Testing, and Approval of Persons Qualified to Test Device

I, Jamie Andrew Chalker, Commissioner of Police:

- 1. Under section 44(1) of the *Traffic Act 1987* ("the Act"), on being satisfied of the matters referred to in section 44AA of the Act as applicable, approve as a traffic infringement detection device each device that is of a kind identified in Column A of Schedule 1 and described in section 2 of the document specified opposite in Column B.
- Under section 44(2)(a) of the Act, specify that, subject to paragraph 3 below, testing of the accuracy of a device that is of a kind identified in Column A of Schedule 1 must be carried out by an approved person:
  - (a) in the manner described in section 3 of the document specified opposite in Column B;
  - (b) at the frequency described in section 4 of the document specified opposite in Column B.
- 3. Under section 44(2)(a) of the Act, specify that, in respect of a device which is of a kind identified in Column A of Schedule 1, where a function of the device which is essential to the detection of a particular kind of offence is not tested by an approved person:
  - (a) in the manner described in section 3 of the document specified opposite in Column B; or
  - (b) at the frequency described in section 4 of the document specified opposite in Column B,

the device must not be used for or in relation to the detection of an offence of that kind until the relevant function has been tested in the manner described in section 3 of the document specified opposite in Column B.

4. Under section 44(3) of the Act, in respect of each device that is of a kind identified in Column A of Schedule 1, approve each person listed in Schedule 2 as a person qualified to test the accuracy of the device.
