Dangerous Goods Regulations 1985

Approval of Periods for Purchasing, Possessing and Throwing, Igniting or Exploding Shopgoods Fireworks

I, Selena Jane Malijarri Uibo, Attorney-General and Minister for Justice:

- (a) under regulation 139 of the *Dangerous Goods Regulations 1985*, approve the period of time from 9 am to 9 pm on Thursday 1 July 2021 as a period during which a person may purchase shopgoods fireworks; and
- (b) under regulation 140(1) of the Regulations and with reference to regulation 140A(1) of the Regulations:
 - (i) approve the period of time from 9 am on Thursday 1 July 2021 to 12 noon on Friday 2 July 2021 as a period during which a person may possess shopgoods fireworks, subject to the condition that this approval does not apply to the place specified in the Schedule; and
 - (ii) approve the period of time from 6 pm to 11 pm on Thursday 1 July 2021 as a period during which a person may throw, ignite or explode shopgoods fireworks, subject to the condition that this approval does not apply to the place specified in the Schedule.

Schedule

All that parcel of land at Mindil Beach in the Town of Darwin, Northern Territory of Australia bounded by lines described as follows:

Commencing at the intersection of the north-westerly prolongation of the north-eastern boundary of Lot 5244 with the Low Water Mark of Fannie Bay; then south-easterly by the said prolongation and boundary and its south-easterly prolongation to the north-easterly prolongation of the north-western boundary of Lot 5257; then south-westerly to the northern corner of the said Lot; then south-easterly by its north-eastern boundary to a north-western boundary of Gilruth Avenue; then generally north-easterly by the said boundary to intersect parallel of south latitude 12 degrees 26 minutes 33.9 seconds, being a point on the centreline of a stormwater drain exiting under Gilruth Avenue; then generally north-westerly by the centreline of the said drain to intersect a south-western boundary of Lot 5670; then north west by the said boundary to the Low Water Mark of Fannie Bay; then generally south-westerly by the said Low Water Mark to the point of commencement, the position of Low Water Mark referred to being as at Lowest Astronomical Tide.

Water Act 1992

Revocation of Declarations and Declaration of Exemptions

I, Vicki Susan O'Halloran, Administrator of the Northern Territory of Australia, acting with the advice of the Executive Council and in accordance with the recommendation of the Minister for Environment:

- (a) under section 44(8) and 47(1) of the *Water Act 1992* and with reference to section 43 of the *Interpretation Act 1978*, revoke the declarations made by the instrument entitled "Revocation of Declarations and Declaration of Exemptions" dated 9 April 2020 and published in *Gazette* No. G15 on 15 April 2020; and
- (b) under section 44(8) of the *Water Act 1992* and with reference to section 42 of the *Interpretation Act 1978*, make the declaration set out in the Schedule, Part A; and
- (c) under section 47(1) of the *Water Act 1992* and with reference to section 42 of the *Interpretation Act 1978*, make the declaration set out in the Schedule, Part B.

Schedule

Part A – Exemptions under section 44(8)

Section 44(1) and (2) of the *Water Act 1992* do not apply to or in relation to:

- (a) the taking of water for the purpose of filling a rural dam that has a bank height of less than 3 m and a catchment area of less than 5 km²; and
- (b) the use of water for recreational purposes.

Part B – Exemptions under section 47(1)

1 Interpretation

(1) In this Part:

general purpose bore – high rate means a bore or proposed bore that:

- (a) is more than 3 m deep; and
- (b) is not a special purpose bore; and
- (c) provides and is equipped to supply an instantaneous discharge rate at ground surface in excess of 15 L per second.

general purpose bore – low rate means a bore or proposed bore that:

- (a) is more than 3 m deep; and
- (b) is not a special purpose bore; and
- (c) does not provide and is not equipped to supply an instantaneous discharge rate at ground surface in excess of 15 L per second.

shallow bore means a bore, or proposed bore, that is, or when completed will be, not more than 3 m deep.

special purpose bore means a bore or proposed bore that is more than 3 m deep and constructed or used for the purposes of:

- (a) carrying out site investigations for the foundations of a building, road or cutting; or
- (b) constructing the foundations of a building, road or cutting; or

- (c) extracting water from the area occupied by foundations of a building, road or cutting; or
- (d) locating materials necessary for the construction of a road or earthen structure.

stock and domestic purpose bore means a bore or proposed bore that is, or when completed will be, used in accordance with section 14 of the Act.

WCD means a water control district declared for ground water management purposes.

- (2) For this Part, the depth of a bore is measured from the natural ground surface to the bottom of the bore.

2 Bores

- (1) The provisions of Part 6 of the Act specified in the Table below do not apply to or in relation to a bore of a class and in the location indicated.
- (2) This exemption does not apply in relation to a bore outside a WCD if a proposed beneficial use of water from the bore is a petroleum activity.
- (3) From 1 January 2022, this exemption does not apply in relation to a bore outside a WCD if a proposed beneficial use of water from the bore is a mining activity.
