



# **Workers Rehabilitation and Compensation Advisory Council Members – Expressions of Interest**

The Attorney-General and Minister for Justice invites nominations from any organisation or person claiming to represent the interests of employers, workers, insurers or professional persons concerned with medical and rehabilitation treatment of injured workers to be a member on the Workers Rehabilitation and Compensation Advisory Council.

Those persons with a wide range of experience with the statutory scheme for the rehabilitation and compensation of injured workers in the Northern Territory are encouraged to put forward a nomination.

The Workers Rehabilitation and Compensation Advisory Council comprises of no more than ten members appointed by the Minister and a member constituting the Work Health Authority.

The Council has the following functions:

- (a) to keep the operation of the Return to Work Act 1986 under review;
- (b) to make recommendations to the Minister on possible improvements to the administration of the Act, or the statutory scheme for the rehabilitation and compensation of injured workers in the Territory;
- to carry out investigations, at the request of the Minister, into questions about the rehabilitation and compensation of injured workers and to report to the Minister on the results of the investigations;
- (d) to perform any other advisory functions relating to workers rehabilitation and compensation as the Minister directs.

An appointed member holds office for the period, not exceeding two years, specified in the instrument of appointment. Sitting fees are available to members.
