Housing Act 1982

Determination of Rent Payable for Dwellings: Affordable Housing Scheme

- I, Ngaree Jane Ah Kit, Minister for Urban Housing, with effect commencing on 1 July 2024:
- (a) under section 23 of the Housing Act 1982 and with reference to section 43 of the Interpretation Act 1978, revoke the instrument entitled "Determination of Rent Payable for Dwellings: Affordable Housing Scheme" dated 28 June 2023 and published in Gazette No. S46 of 30 June 2023; and
- (b) under section 23 of the Housing Act 1982, determine that the rent to be paid per week for a dwelling that is leased under the scheme described in Schedule 1 and that is of a class and at a location specified in a table in Schedule 2 is the amount specified opposite the location in the column relating to the class of dwelling in Schedule 2.
