Amendment of Instrument

Declared Areas Cattle Ticks (*Rhipicephalus Microplus*) Parkhurst Strain

I, Malcolm Laurence Anderson, Chief Inspector of Livestock, under section 59(1) of the *Livestock Act* and with reference to section 43 of the *Interpretation Act*, amend the instrument entitled "Declared Area Movement Restrictions Cattle Ticks (*Rhipicephalus Microplus*) Parkhurst Strain" published in *Gazette* No. G23 of 8 June 2011 as follows:

- (a) after clause 5(5), by inserting a new clause 5(6):
 - (6) A requirement for injectable macrocyclic lactone treatment is met if the livestock is:
 - (a) treated with an injectable macrocyclic lactone registered by the Australian Pesticides and Veterinary Medicines Authority established under the *Agricultural and Veterinary Chemicals (Administration) Act 1992* (Cth); and
 - (b) the treatment is conducted at a registered premises, as defined in section 2.01 of the *Export Control (Animals) Order 2004* (Cth).

- (b) by omitting the table entitled "Table, Supervised Treatment Requirements" and replacing it with the following:

Table	Supervised Treatment Requirements	
Livestock	Treatment type	When treatment required
cattle buffalo	injectable macrocyclic lactone	between 3 and 14 days before movement starts
cattle buffalo	plunge dip	within 24 hours before movement starts or any longer period (not exceeding 48 hours) approved by an inspector
alpacas camels goats sheep	spray dip	within 24 hours before movement starts or any longer period (not exceeding 48 hours) approved by an inspector
