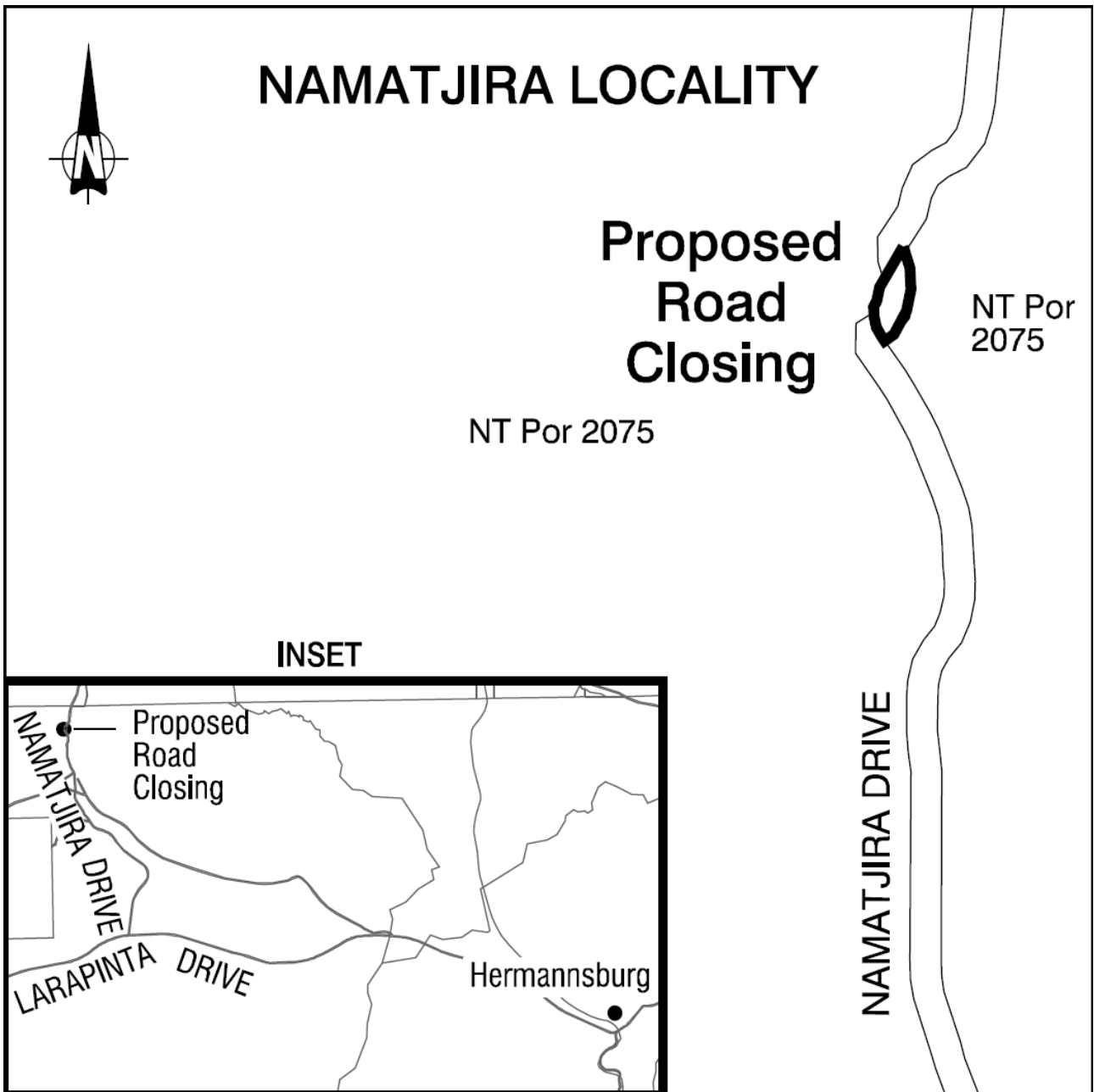
Notes
