## NLIS for shows, rodeos, sporting events in the NT

All properties where cattle are held in the Northern Territory are required to be identified by a Property Identification Code (PIC). This includes showgrounds and rodeo grounds.

It is mandatory to use RFIDs for cattle moving from property to property in the NT, this also applies to showgrounds and rodeo grounds. The owner of a showground or rodeo ground will be responsible for ensuring that a transaction is recorded to the NLIS database for all cattle arriving at the showground or rodeo ground.

If any cattle are found that are not identified with a RFID the ground owner will be required to attach a post breeder device (purchased for use at the property) prior to the cattle leaving the showground or rodeo ground.

If an event is held on a property and the cattle are sourced from the same property there is not a property to property movement and no transaction is recorded to the NLIS database.
