2. Definition


In this amendment -

3. Amendment of Zoning Map

NT PLANNING SCHEME AMENDMENT

AMENDMENT No. 143

Reasons for Decision

The rezoning sites are part Sections 2934, 4018 & 4534, Sections 3995 & 3996 and Lots 1,2 & 10-15 LTO 77/015 Hundred of Strangways from Zone RL (Rural Living) to Zone RR (Rural Residential) in the Virginia locality of Litchfield Shire.

The exhibited version of the application proposed part Sections 2934 and 4018 and Sections 3818, 3990, 3991, 3992, 3993, 3994, 3995, 3996, 4534, and LTO 77/015 Lots 1, 2, 10, 11, 12, 13, 14, 15 Hundred of Strangways be rezoned from Zone RL (Rural Living) to Zone RR (Rural Residential) to facilitate the development of a rural residential subdivision.

During the exhibition period the owners of Sections 3818, 3990 - 3994, Hundred of Strangways requested that their lots be removed from the application, and I have amended the rezoning application to reflect this appeal.

The sites will be rezoned from RL (Rural Living) to Zone RR (Rural Residential) and will be designated as "Restricted Rural Residential", under clause 10.2(5) of the Northern Territory Planning Scheme.

The rezoning will facilitate a rural residential subdivision that is consistent with the capabilities of the land, provided the continued enjoyment of the natural environment by the current residents whilst providing a balance of rural lifestyle for future residents. Additionally the designation of the land as Restricted Rural Residential will limit the clearing of native vegetation, provide a pleasant living environment for the future residents and prevent soil erosion into Darwin Harbour.
