#### **Reasons for Decision**

# NORTHERN TERRITORY PLANNING SCHEME AMENDMENT No. 387

I have approved an amendment to the Northern Territory Planning Scheme that introduces:

- two new Northern Territory Planning Principles relating to compact urban growth and social infrastructure at clause 4.1; and
- a new document titled the "Northern Territory Compact Urban Growth Policy", which is to be included as a Reference to Policy document at the Schedule to clause 2.7.

These changes will provide a consistent and transparent set of benchmarks that will assist a decision maker in determining the merits of higher density residential development proposed by an area plan, a rezoning application or an exceptional development application. Further, these changes will provide improved certainty to the development industry and the community about where compact urban growth may occur.

Some additional benefits of encouraging compact urban growth in appropriate locations include:

- reducing our consumption of greenfield land such land may otherwise be better used for environmental or food growing purposes;
- an improved carbon footprint and reduced travel times as new developments will occur near existing employment and service locations; and

 increasing the diverse supply of housing types which match the changing needs of the community.
