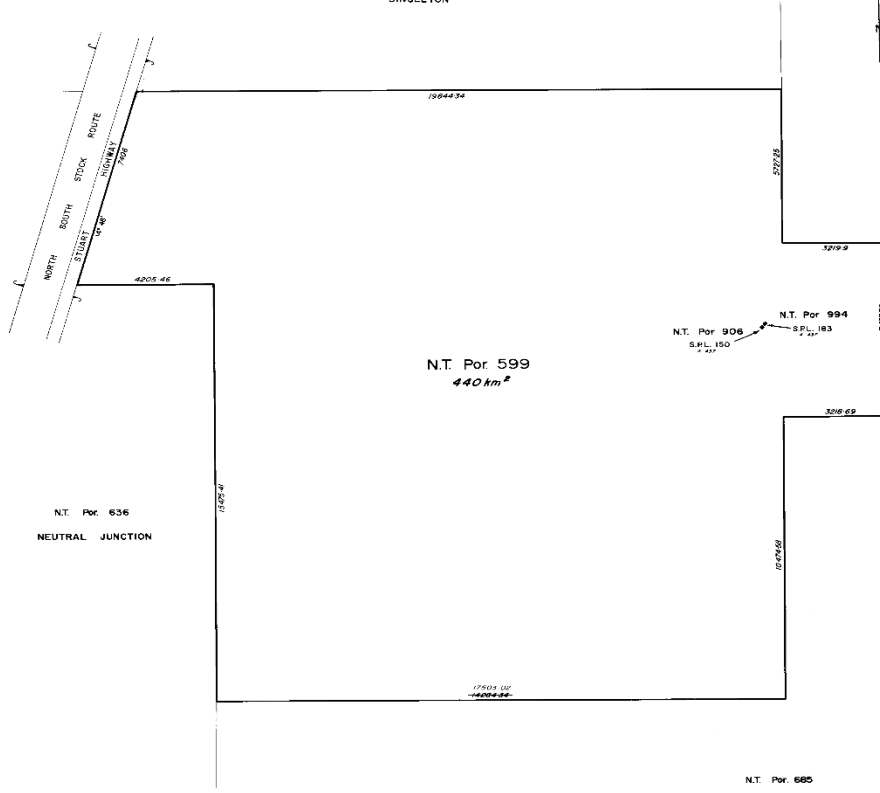

***Legal Profession Act 2006***
