



Application for a Travel Payment (Friend or Relative of

Member) (Other than by private motor vehicle)

Information for members

Your Travel Voucher may be used for your nominated friend or relative to visit you in the Northern Territory provided that they live at least 50 kilometres from your place of residence. You can claim your Travel Voucher upfront if you make the booking through a travel agent recognised as an Approved Vendor under the NT Senior Recognition Scheme (Scheme). This form is only relevant if the traveller makes the booking themselves or if the booking is made on their behalf through a non-Approved Vendor.

- Step 1: Complete the Travel Details attached to your Travel Voucher (please place "Friend or Relative Travel" next to the following fields: "Provider Name", "ABN", "Authorised Officer", "Phone", "Total value of travel" and "Ref Number"). Please ensure that the traveller's full name is inserted.
- Step 2: Ensure that this form is completed by the traveller and returned to you.
- Step 3: Please complete Sections 1 and 2 below.
- Step 4: Submit this form, including any supporting documentations and your Travel Voucher, along with your signed declaration under your Travel Voucher, to the NT Concessions and Recognition Unit at your nearest shop front, via post to PO Box 37037, Winnellie NT 0821 or email ntconcessionandrecognition@nt.gov.au
