In accordance to section 20 of the *Motor Vehicles Act 1949*, where a motor vehicle is sold, the former owner must notify the Motor Vehicle Registry (MVR); this is known as lodging a notice of disposal.

A notice of disposal will exempt the former owner from any liabilities, such as traffic fines or offences and identify the right person responsible.
