### Authorised Operators of Prescribed Breath Analysis Instrument and Drug Analysis Instrument

I, Hege Ronning-Burns, Commander, College Command, as a delegate for the Commissioner of Police in pursuance of section 27B(2) of the *Traffic Act 1987* and regulation 59 of the *Traffic Regulations 1999*, being of the opinion that each member of the Northern Territory Police Force whose name appears in the attached Schedule is:

- (a) trained in the use of a prescribed breath analysis instrument known as the Drager Alcotest 7110; or
- (b) trained in the use of a prescribed breath analysis instrument known as the Drager Alcotest 9510; or
- (c) trained in the use of a prescribed drug analysis instrument known as the Drager DrugTest 5000; and
- (d) capable of using the prescribed instruments correctly.

I authorise those members of the Northern Territory Police Force to use the prescribed Breath Analysis instruments or Drug Analysis instrument for the purpose of the *Traffic Act 1987*.
