

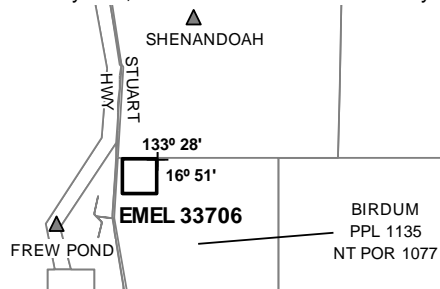

### Objections or Submissions to mineral title applications (s71 [3])

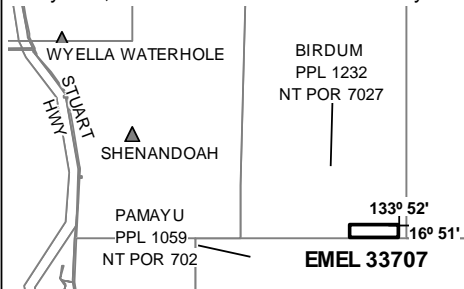

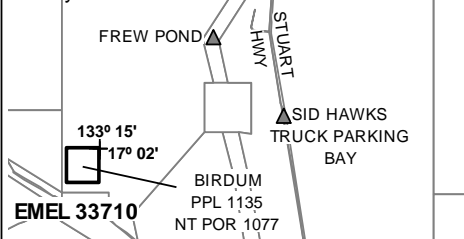

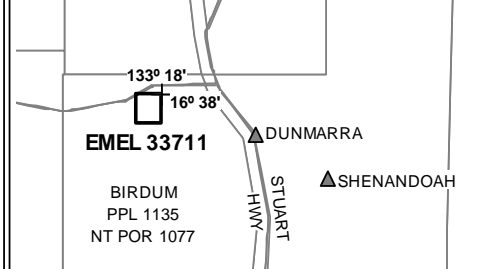
