Notice pursuant to the *Catholic Church in the Northern Territory Act 1979* (NT)

Notice of Establishment of Catholic Church Diocese of Darwin Management Property Trust

Notice is given, pursuant to sections 3 and 6 of the *Catholic Church in the Northern Territory Act 1979* (NT) that I Charles Gauci, the Bishop of the Diocese of the Catholic Church of Darwin make the following By-laws which may be cited as the *Catholic Church of the Diocese of Darwin Management Property Trust By-laws*:

1. There is established by these By-laws a management property trust in respect of the Catholic Church of the Diocese of Darwin.
2. The name of the property trust established by By-law 1 is the Catholic Church of the Diocese of Darwin Management Property Trust.
3. That a matter relating to the regulation, management or administration of the property trust established by By-law 2 may be provided for by rules, not inconsistent with the Act or the by-laws made by the property trust from time to time.
4. The address for service of notices of the Catholic Church of the Diocese of Darwin Management Property Trust will be GPO Box 476, Darwin NT 0820.
