Plant Health Act 2008

Termination of Appointments and Appointment of Chief Inspector of Plant Health and Acting Chief Inspector of Plant Health

I, Gerard Phillip Maley, Minister for Agriculture and Fisheries:

- (a) under section 47(1) of the *Plant Health Act 2008* (the **Act**) and with reference to section 44(1) of the *Interpretation Act 1978*, terminate the appointment of Anne Christine Walters as the Chief Inspector of Plant Health; and
- (b) under section 47(1) of the Act and with reference to section 47(3) of the Act, appoint Sally Ann Heaton to be the Chief Inspector of Plant health for 3 years; and
- (c) under section 52(1) of the Act and with reference to section 44(1) of the *Interpretation Act 1978*, terminate all appointments of persons to act as the Chief Inspector of Plant Health in force immediately before the date of this instrument; and

- (d) under section 52(1) of the Act, appoint Stanley Edward Bellgard to act as the Chief Inspector of Plant Health during all periods when:
 - (i) one of the following applies:
 - (A) the Chief Inspector is absent from duty;
 - (B) the Chief Inspector is otherwise unable to exercise the powers, or to perform the functions, of the Chief Inspector;
 - (C) the office of the Chief Inspector is vacant; and
 - (ii) no other person has been appointed to act as the Chief Inspector during the particular period of absence, inability or vacancy; and
- (e) under section 52(1) of the Act, appoint John Edward Nielsen to act as the Chief Inspector of Plant Health during all periods when:
 - (i) a circumstance mentioned in paragraph d(i) applies; and
 - (ii) Stanley Edward Bellgard is unable, for any reason, to act as the Chief Inspector; and
 - (iii) no other person has been appointed to act as the Chief Inspector during the particular period of absence, inability or vacancy.
