Pastoral Land Act 1992

Permitted Clearing of Pastoral Land

The Pastoral Land Board, under section 91D of the *Pastoral Land Act 1992* and with reference to section 42 of the *Interpretation Act 1978*, determines that clearing pastoral land is permitted without a clearing permit in the circumstances where the clearing is for the following purposes:

- (a) establishing gravel extraction areas required to carry out public road works;
- (b) carrying out ancillary works such as constructing and maintaining temporary laydown areas in relation to public road works.

Motor Vehicles Act 1949 and Traffic Act 1987

Amendment of Exemption from *Motor Vehicles Act 1949, Traffic Act 1987 and Motor Vehicles (Standards) Regulations 2003*

I, Cindy-Lee McDonald, Registrar of Motor Vehicles, under section 135 of the *Motor Vehicles Act 1949* and section 43B of the *Traffic Act 1987*, and with reference to section 43 of the *Interpretation Act 1978*, amend the instrument dated 15 November 2023 entitled 'Exemption from *Motor Vehicles Act 1949, Traffic Act 1987 and Motor Vehicles (Standards) Regulations 2003*' published in *Gazette* No. G24 of 23 November 2023 (the *Instrument of Exemption*) by omitting 31 March 2026 and inserting instead 31 May 2026, with effect that the exemptions granted by the Instrument of Exemption are to continue in force until 31 May 2026.
