Control of Roads Act

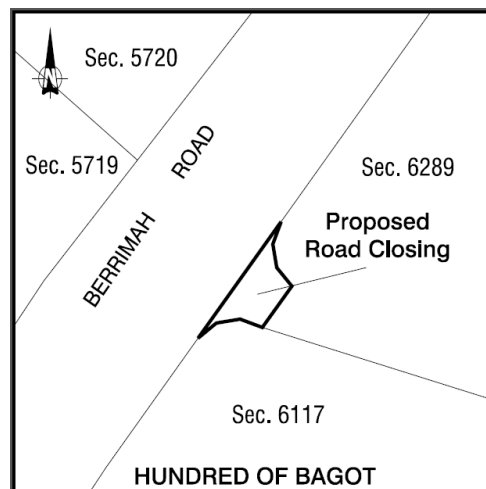
Order to Close Road

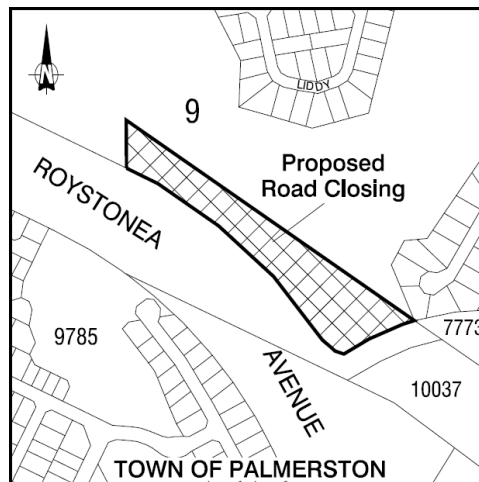
