Livestock ActDECLARED AREA MOVEMENT RESTRICTIONS
CATTLE TICKS (RHIPICEPHALUS MICROPLUS)
PARKHURST STRAIN

I, BRIAN LESLIE RADUNZ, Chief Inspector, under section 59(1) of the *Livestock Act*, restrict the movement of livestock as set out in the Schedule.

SCHEDULE

1 Definitions

In this Schedule:

Parkhurst Cattle Ticks Zone Declaration means the instrument entitled "Declared areas cattle ticks (Rhipicephalus microplus) Parkhurst strain" dated 9 May 2011 and published in *Gazette* No. G20 of 18 May 2011.

Parkhurst Infected Zone means the area declared to be an Infected Zone under the Parkhurst Cattle Ticks Zone Declaration.

restricted livestock means cattle, buffalo, camels, alpacas, goats and sheep.

ticks means cattle ticks (Rhipicephalus microplus) Parkhurst strain.

2 Livestock unloaded taken to start new movement

If restricted livestock being moved from one place to another is unloaded before reaching its destination, the restrictions imposed by this declaration apply separately to:

- (a) the movement from the starting place to the place of unloading; and
- (b) the movement from the place of unloading to the destination.

3 Requirement for inspection, treatment and movement permit

(1) If restricted livestock in the Parkhurst Infected Zone is to be moved out of the Parkhurst Infected Zone, the owner of the livestock must ensure that the movement does not start unless:

- (a) the livestock meets the requirement of:
 - (i) a clean inspection; and
 - (ii) supervised treatment; and
- (b) a declared area movement permit has been granted for the movement.

(2) However the livestock may be moved out of the Parkhurst Infected Zone for the purpose of being given treatment if authorized under clause 5(3).

(3) Further, the Chief Inspector may authorise the movement of the livestock without compliance with subclause (1)(a) if satisfied there are good reasons for doing so.

4 Clean inspection

(1) A requirement for a clean inspection is met if an inspector, having inspected the livestock, declares it to be free of visible ticks or free of ticks containing bodily fluids.

(2) The inspection must be carried out:

- (a) on the day on which the required treatment is carried out, or any earlier day approved by an inspector; and
- (b) before the required treatment is carried out.

5 Supervised treatment

(1) A requirement for supervised treatment is met if the livestock is treated in accordance with the requirements set out in the Table.

(2) All supervised treatments must be carried out under the supervision of, and in the manner approved by, an inspector.

(3) An inspector may authorise the movement of the livestock to a place outside the Parkhurst Infected Zone for the purpose of enabling the livestock to be given treatment by plunge dip.

(4) A requirement for plunge dip or spray dip treatment is met if the livestock is:

- (a) for a plunge dip - fully immersed in Amitraz; or
- (b) for a spray dip - thoroughly sprayed with Amitraz.

(5) A requirement for treatment with Amitraz is met if the livestock is treated with Amitraz in accordance with the instructions of the manufacturer.

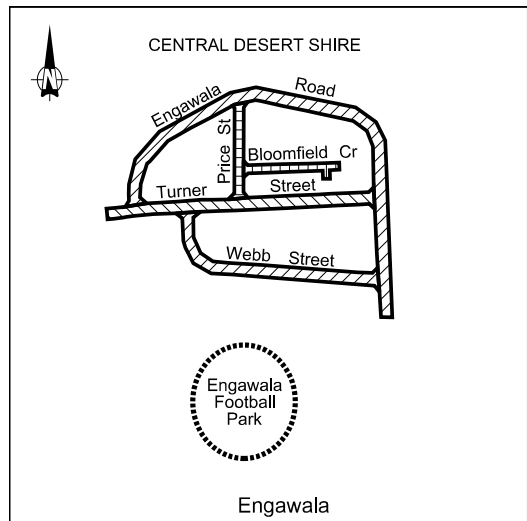
