Major Cricket Events Act

Declaration of Major Cricket Event

I, Matthew Escott Conlan, Minister for Sport, Recreation and Racing, under section 4 of the *Major Cricket Events Act* and with reference to section 5 of the Act:

- (a) declare the following to be a major cricket event:
 - (i) the Victoria v Queensland Sheffield Shield Match to be held from 25 February 2015 to 28 February 2015 at Traeger Park Oval, Speed Street, Alice Springs; and
 - (ii) Victoria v Tasmania Sheffield Shield Match to be held from 13 March 2015 to 16 March 2015 at Traeger Park Oval, Speed Street, Alice Springs; and
- (b) specify that:
 - (i) this declaration is in force during the period when the major cricket event is held; and
 - (ii) the *Major Cricket Events Act* and *Major Cricket Events Regulations* apply in relation to the major cricket event.
