Distinctive Brands in the Northern

No Distinctive (symbol) brand with 3 characters

A symbol brand must be a maximum of 2 letters with a over, under, vertical symbol. A symbol Brand cannot be 3 equal sized letters or characters and not be a 3 character Brand registered in another State. Single letters are not accepted.

Size of Distinctive (symbol) Brands

A distinctive (symbol) brand shall not be less than 4cm high and wide or no more than 12cm high or wide. The imprint surface of the irons is to be no more than 4mm wide and no less than 3mm wide.















It is recommended that any adjacent lines of a distinctive brand be at least 20mm apart to avoid blotching.

A full scale drawing of the required Distinctive (symbol) brand is required in the space provided below.

If, in the opinion of the Registrar or their delegate, a distinctive brand produced from the chosen design would not be clearly legible the distinctive brand will not be registered.
