

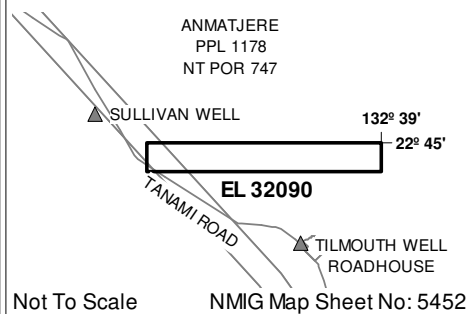
NOTICE OF PROPOSED GRANT OF EXPLORATION LICENCES

MINERAL TITLES ACT 2010 SECTION 71 NATIVE TITLE ACT 1993 (CTH) SECTION 29

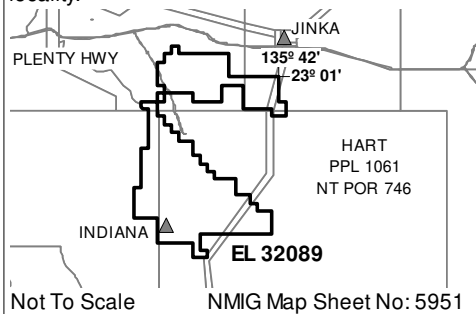
The Honourable Paul Kirby MLA, the Northern Territory Minister for Primary Industry and Resources, and the Chief Executive, Department of Primary Industry and Resources, GPO Box 4550 DARWIN NT 0801, hereby gives notice in accordance with section 29 of the *Native Title Act 1993* (Commonwealth) and section 71 of the *Mineral Titles Act 2010* respectively of the intent to do an act, namely to grant the following exploration licence applications.

Applications to which this notice applies:

Exploration Licence 32090 sought by MIOXIDE AUSTRALIA PTY LTD, ACN 052 522 111 over an area of 9 Blocks (29 km²) depicted below for a term of 6 years, within the NAPPERBY locality.



Exploration Licence 32089 sought by TYPHON MINERALS PTY LTD, ACN 614 887 464 over an area of 250 Blocks (790 km²) depicted below for a term of 6 years, within the QUARTZ locality.



Nature of act(s): The Term of an exploration licence under the *Mineral Titles Act 2010* authorises the holder to conduct activities in connection with exploration for minerals for a term not exceeding 6 years and to seek renewal(s). The term for which it is intended to grant the exploration licence/s referred to in this notice commences from the date of grant. Native Title Parties: Any person who is, or becomes a "native title party" within the meaning of the *Native Title Act 1993* is entitled to the negotiation and/or procedural rights provided in Part 2, Division 3, Subdivision P of the *Native Title Act 1993*. Under section 30 of the *Native Title Act 1993*, persons have until 3 months after the notification day to take certain steps to become native title parties in relation to this notice. Enquiries concerning becoming a native title party should be directed to the National Native Title Tribunal, GPO Box 9973, Melbourne VIC 3001, or telephone (03) 9920 3000.

Expedited Procedure: The Northern Territory Government considers that the acts are acts attracting the expedited procedure as defined in section 237 of the *Native Title Act 1993*. The exploration licences referred to in this notice may be granted unless an objection is made by a native title party to the statement that the act is one which attracts the expedited procedure. Such an objection must be made to the National Native Title Tribunal within 4 months of the notification day.

Objection or Submission, Section 71 of the *Mineral Titles Act 2010*: The landowner(s) of land in respect of which the following applications are made, may lodge an objection to the grant of the exploration licence application; any other persons may lodge a submission. Objections and submissions must be lodged in writing with the Department of Primary Industry and Resources, at the above mentioned address or emailed to titles.info@nt.gov.au, within 30 days from the relevant Notification Date which is set out below.
