#### Reasons for Decision

# NORTHERN TERRITORY PLANNING SCHEME AMENDMENT No. 474

NT Portions 7234 and 7235 Alice Springs (Suburb of Kilgariff) are suitable for rezoning from Zone FD (Future Development) to Zone SD (Single Dwelling Residential), Zone MD (Multiple Dwelling Residential) and Zone U (Utilities) as it will implement the zoning for Stage 1(b) of Kilgariff and associated infrastructure and is generally reflective of the indicative zoning plan that was endorsed as part of Development Permit DP13/0865.

The proposed amendment is considered to be a normalisation process of amending the NT Planning Scheme by introducing standard zones that better reflect the proposed land uses to enable residential development and management of utilities in a manner that is consistent with the provisions of the NT Planning Scheme.

# AMENDMENT TO NT PLANNING SCHEME AMENDMENT No. 474

#### 1. Citation

This amendment to the NT Planning Scheme may be cited as Amendment No. 474.

### 2. Definition

In this amendment -

"amending map" means the map, signed by the Minister for Infrastructure, Planning and Logistics and marked "NT Planning Scheme Amendment No. 474", deposited in the office of the Department of Infrastructure, Planning and Logistics, Darwin;

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

# 3. Amendment of Zoning Map

The NT Planning Scheme is amended by amending the zoning map relating to Alice Springs to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered SD, MD and U which is part of NT Portions 7234 and 7235, Stuart Highway and Colonel Rose Drive, suburb of Kilgariff.
