Weeds Management Act 2001

Revocation of Appointment and Appointment of Authorised Persons

I, Alaric Fisher, Acting Chief Executive Officer of the Department of Environment, Parks and Water Security, as the delegate of the Minister for Environment:

- (a) under section 25(1) of the *Weeds Management Act 2001* and with reference to section 43 of the *Interpretation Act 1978*, revoke any instruments appointing authorised persons that are in force immediately before the date of this instrument is published in the *Gazette*.
- (b) under section 25(1) of the *Weeds Management Act 2001*, and in reference to section 25(2) of the Act, appoint each person named in the Schedule to be an authorised person to exercise the powers of an officer under section 28(1)(a) of the Act.

Petroleum Act 1984

Release of Information under Section 61(8)

I, Louis Gomas, the Delegate of the Minister for Mining and Industry, in pursuance of section 61(8) of the *Petroleum Act 1984* –

- (a) notify that I propose to make the information specified in the Schedule available or publicly known;
- (b) invite interested persons to give to me, within 45 days after the publication of this notice, a notice objecting to the whole or any part of the information being made available or publicly known; and
- (c) notify that if a person does not make an objection in accordance with this invitation, the person will be taken to have consented to the information being made available or publicly known.

Note

- 1. A notice objecting to information being made available or publicly known shall set out the person's reasons for making the objection.
- 2. A person may not object to information being made available or publicly known except on the ground that –
 - (a) a trade secret; or
 - (b) any other information the disclosure of which would, or could reasonably be expected to, adversely affect the person in respect of the lawful business, commercial or financial affairs of the person.
