Notice of Issue of Electricity Pricing Order

- (b) the order will have the effect of regulating prices for the sale of electricity to those customers for the period from 1 July 2022 to 30 June 2023; and
- (c) a copy of the order may be inspected at, and obtained from, any office of the Power and Water Corporation, Jacana Energy or any other person licensed under Part 3 of the *Electricity Reform Act 2000* to sell electricity.

Water Supply and Sewerage Services Act 2000

Notice of Issue of Pricing Orders

- (a) a pricing order regulating prices for the sale of water supply and sewerage services was issued on 1 June 2022 (the ***initial order***); and
- (b) a further pricing order (the ***replacement order***) revoking the initial order and regulating prices for the sale of water supply and sewerage services has been issued; and
- (c) the replacement order will have the effect of regulating those prices from 1 July 2022 to 30 June 2023; and
- (d) a copy of the replacement order may be inspected at, and obtained from, any office of the Power and Water Corporation or any other person licensed under the *Water Supply and Sewerage Services Act 2000* to provide water supply services or sewerage services.
